2109/484 Declarations of interest

Members were reminded that all interests should be declared prior to the item being discussed.

2109/485 To agree the agenda as published

It was **resolved** to agree the agenda as published after moving item 23 to follow item 8.

2109/486 To confirm and sign the minutes of the Town Projects Meeting held 5th July 2021 as a correct record

2109/487 Public Participation

2109/488 To consider Action Points

Action Points were noted. The Town Clerk was asked to write to Torridge regarding Blackies and request a time limit for the transfer.

Action Point - Town Clerk to write to Torridge District Council.

2109/489 To consider an update on the information boards at Bone Hill

It was **resolved** to suspend Standing Orders.

It was proposed by Cllr Leather that the detail in the report be accepted. There was no seconder for this proposal.

It was further **resolved** to accept the proposed revised text. There were 4 votes in favour, 2 against and 1 abstention)

2109/490 To consider an update in relation to Northam Lions Football Club's application to the Football Foundation

It was **resolved** to submit an application to the Contracts Finder with a closing date of 4 weeks for receipt of applications.

Action Point - Town Clerk to submit application

2109/494 To consider an update on a resident's request for specimen tree planting along Golf Links Road, between Beach Road and Avon Lane

It was **resolved** to pursue the matter with SSE and Highways requesting more detailed information.

Proposed: Cllr Leather, seconded: Cllr Edwards (5 in favour, 2 abstentions)

Action Point - Town Clerk to pursue the matter with SSE and Highways

2109/495 To consider an update on the cost of repair of outdoor gym equipment at Burrough Farm and its removal to Lords Meadow

It was **resolved** to proceed with repairing and moving the equipment as soon as possible. Actual siting at Lords Meadow to be agreed.

Proposed: Cllr Leather, Seconded: Cllr Mrs Hodson (6 in favour, 1 abstention)

Action Point – Proceed with repairing and moving the equipment and

Town Clerk to investigate possibility of funding from the Welcome Back

fund.

2109/496 To consider an update on Footpaths (Cllr Hames)

It was **resolved** to proceed as soon as possible with the work required on two of the footpaths, which had recently been inspected and require work. Proposed: Cllr Hames, Seconded: Cllr Tisdale (all in favour)

2109/497 To consider an update on installation of dog bins including Orchard Hill and a request for additional sites

Members had received a map showing all the dog bins installed in the area below Heywood Road roundabout (thanks to Richard Haste Torridge District Council).

It was **resolved** that there were sufficient dog bins around the Riverside Court area

Proposed: Cllr Tisdale, Seconded: Cllr Mrs Hodson, (majority in favour, 1 abstention)

Action Point – Town Clerk to contact the relevant Councillor and also request a map of the entire area showing all the dog bin sites which will be posted on Northam Town Council's website.

2109/498 To consider bee friendly planting outside the Town Hall

It was proposed by Cllr Hames and seconded by Cllr Edwards that the Council plant a selection of bee friendly shrubs directly into the soil. There was an amendment to this proposal that Members accept the report and two planters (made, if possible from recycled plastic) be purchased and it was so **resolved**. Proposed: Cllr Leather, Seconded: Cllr Mrs McCarthy (5 in favour, 2 against) **Action Point – Proceed with purchase of planters**.

2109/499 To consider an update on planting at Anchor Park to include funding Cllr Hames advised that he will firm up the proposals for the next agenda.

2109/500 To consider hire of scaffolding to enable the front of the Town Hall to be decorated

It was **resolved** that we write to Torridge District Council noting that the building needs redecoration and there are acoustic issues which need to be met to comply with DDA. The entire fabric of the building requires redecoration. Proposed: Cllr Mrs Hodson, Seconded: Cllr Edwards (all in favour)

The Town Clerk was also asked to report that the exterior of the building is in an appalling state and there is considerable danger from falling slates.

Action Point - Town Clerk to write to Torridge District Council
