The 200 club now has 155 members, it now costs £10 to join.

Mr Makeig-Jones advised the trellis panels have all been installed and compliments received on the professional job done.

The "Hotbin Composter" has arrived and installation is awaited. The Biosphere attendees at the "Hotbin" presentation advised there are grants of seeds available.
