The Rest Centre is a Grade II listed former school house (listing no. 1267142), being established by Elizabeth Thorrold in 1888.

It has been used in recent years as a community building, hosting a number of social and community groups and classes until the committee disbanded around a year ago. Northam Town Council included the building as part of its annual May Fair festivities, with the committee holding events during the day of the annual fair. In 2024, the Council used the Rest Centre as the location for invited dignitaries to gather away from the crowds and enjoy light refreshments.

Prior to the committee disbanding, there were regular groups and classes:

Tuesday – Saturday Coffee Morning, Up to 25 people

Monday Night - Bingo, average 50 people

Tuesday and Friday Night - Bridge Club, average 35 people

Wednesday afternoon - Friendship Club, average 40 people

Wednesday Night - Bingo, average 70 people

Saturday afternoon – Bingo, average 70 people

Sunday night - AA Group, average 30 people.

The Daisy Chain group also used it for 6 months before moving to Morwenna community club when the committee disbanded.

Until its removal in 2006, the water fountain provided by Northam Urban District Council was an important part of the frontage of this building, originally being placed in that location as part of the efforts to bring fresh, clean drinking water to the community of Northam.

Images of the fireplace in the building showing its establishment, the exterior of the building, a historic image of the drinking fountain and the land regsitry plan of the site are attached.

The building is unoccupied. The last tennat (torridge District Council) has terminated its lease with the owners, Westward Housing Group Ltd.

Section 3 - SUPPORTING INFORMATION FOR THE NOMINATION

3. What are the reasons for nomination this land/building for consideration as an asset of community value?

Please provide as much information as possible, including how the asset might promote or improve the social, economic and environmental well-being of the area.

The building is, along with others in Northam Square, listed and of significnat historical and heritage value and interest for the community. The Town Clerk at Northam and the Vicar of St Margarets had been in the early stages of discussions regarding youth club provision. The location was considered ideal as a venue for youth clubs, to attract young people across the ages from year 7 up.

The Town Clerk has consulted with the organiser of the Bingo sessions, who was a member of the committee. He is interested in starting those sessions again but can find no space in Northa, the Community Centre (in Fore Street) and Northam Hall on the corner of Fore St and Atlantic Way) being well-used community facilities with no regular booking spaces available at suitable times.

Prior to the committee disbanding, there were regular groups and classes:

Tuesday - Saturday Coffee Morning, Up to 25 people

Monday Night - Bingo, average 50 people

Tuesday and Friday Night - Bridge Club, average 35 people

Wednesday afternoon - Friendship Club, average 40 people

Wednesday Night - Bingo, average 70 people

Saturday afternoon – Bingo, average 70 people

Sunday night - AA Group, average 30 people.

The Daisy Chain group also used it for 6 months before moving to Morwenna community club when the committee disbanded.

As previously mentioned, St Margaret's Chuurch and the Town Council had been in early discussions regarding its potential use as a youth club venue. Youth clubs provide benefit to the community more widely than simply those attending. "In the short-term, teens who attended youth clubs regularly were less likely to truant from school, less likely to drink alcohol, more likely to have good health, and more likely to want to go to university. There was also evidence that these positive changes persist over time — when they reached aged 20, young adults who had attended a youth club were more likely to be in education and more likely to be a volunteer in their free time".

The Town Council has heard from Libraries Unlimited that the branches in Northam and Appledore could be working reduced hours or removed altogether unless the funding situation improves. The Town Council would look seriously at working with the Library service to maintain a location in Northam.

Annually, Northam Town Council would use the building to support the Northam May Fair, a street fair held on a Saturday in early May each year. This street fair involves children from local schools and community groups, local small businesses and artisan traders and entertainers.
